After the board meeting, Ms. Vivian Bright walked in front of the chair I was sitting in and said "a complete asshole." I initially thought she was referring to Mr. Charvat as he was walking out of the meeting room. However, the more I thought of it, I believe she was referring to me as she said it as she was walking by me. Is this behavior acceptable at HACD?

I have attached a clip of the recording of the meeting. At approximately six seconds, you will hear Ms. Bright say "a complete asshole."

I don't think it is appropriate for a member of the executive team to use such language when referring to a public member attending a public meeting of HACD. It is not appropriate language when referring to a client or another employee of HACD.
